NOTES:

1. Program tuition is charged per credit hour at the beginning of each term throughout the student's program. Each academic term is 10 weeks and includes two 5 week sessions. Students may be required to complete some coursework for their program via online delivery.
2. Total Program Cost displayed is based upon the total number of credits in a degree program. Fees charged by the University are included in the Total Program Cost. The total number of credits taken at Colorado Technical University may vary due to transfer credits, block transfer, repeated courses, or multiple concentrations. Students possessing an earned Associate degree from an accredited institution at the time of admission to Colorado Technical University may be eligible for a block transfer of credits into select Bachelor's degree programs. See the Degree Programs section of the University Catalog for descriptions of the degree programs.
3. The University reserves the right to change tuition and fees during the course of an academic year. As such, a student's financial aid packaging may be subject to adjustment to account for these monetary changes.
4. The Student Senate Fee supports all student activities, student organizations, resources for student needs, and the enhancement of external activities for students. This non-refundable \$5 fee is charged per term and is included in the Total Program Cost displayed above.
5. A non-refundable Student Setup Fee of \$170 will be charged per enrollment for all students in the first course, including those who seek re-entry to the University. The Student Setup Fee supports costs associated with the enrollment process, including access to the Student Portal and Virtual Classroom. Students utilizing VA education benefits will be exempt from this fee.
6. The Technology Fee is \$265 per term (non-refundable). The Technology Fee covers student access to and maintenance of the following University systems: intellipath® adaptive learning platform. CTU Mobile App, CTU Messenger, e-Book reader, and student email. Students utilizing VA education benefits will be exempt from this fee. This Technology Fee amount is applicable for new academic years starting on or after June 9th, 2026.
7. For students enrolled in the Associate of Science in Electronics Technology, Bachelor of Science in Computer Engineering and Bachelor of Science in Electrical Engineering programs, a \$1,100 non-refundable Engineering Fee will be charged to the student's account in the term in which the student is registered for the first engineering (EE) course and is displayed in the Total Program Cost. This fee does not cover the cost of these required items: safety goggles, one Phillips head screwdriver, one flat head screwdriver, and one set of needle nose pliers with side cover; it is the student's responsibility to purchase these items. Engineering students are also responsible for purchasing any replacement parts listed on the Engineering Parts List; this list is available to students to assist in purchasing replacement parts.
8. A non-refundable Graduation Fee will be charged to the student's account during their final term and is included in the Total Program Cost. The Graduation Fee covers one diploma and diploma cover, two official university transcripts, honor cord (if applicable), regalia (if the graduate is attending a ground commencement ceremony), and costs related to the production of the annual ground commencement ceremony. In order to participate in a ground commencement ceremony, each eligible student must complete the entire graduation process by the published deadline. Students who fail to register by the deadline will forfeit the opportunity to receive regalia and participate in a ground commencement ceremony. Regardless of ceremony participation, all graduates will receive their diploma kit at their home address approximately 6-8 weeks following their final term (provided all financial and academic obligations are met).
9. Total Program Cost includes a custom suite of course materials which are provided to the student by Words of Wisdom, LLC. At the University's discretion, books may be delivered in an electronic (e-Book), which may be accessed by the student for the duration of the applicable course(s) or standard textbook, which becomes the property of the student. Students not wishing to use e-Books are responsible for any additional charges associated with purchasing standard textbooks.

Cost of Attendance

The cost of attendance (COA), is the average academic year education-related cost for attending a program at an institution of higher education. Expected charges include direct costs, such as tuition and fees, and indirect costs (not directly charged by the school), such as room and board, travel, books and supplies, and other personal expenses. The COA will differ based on various circumstances, such as your enrollment status and living situation. Students living with their parents should reference the ‘With Parent’ components below. All other students should reference the ‘Off-campus’ components below.

Below are the COA components for the 2025-2026 academic year. At CTU, a full-time academic year consists of three terms, which is generally eight months in length.
