Students possessing an earned Associate degree from an accredited institution at the time of admission to Colorado Technical University may be eligible for a block transfer of credits into select Bachelor degree programs. - Program tuition is charged per credit hour each quarter throughout the student's program, and is charged at the beginning of each quarter. Each academic quarter is 11 weeks, and consists of two 5 1/2 week sessions.
- The university reserves the right to increase institutional tuition rates during the course of an academic year. As such, a student's financial aid packaging may be subject to adjustment to account for these monetary changes.
- Military tuition rate cannot be combined with any other CTU scholarships/grants. Course materials charges are derived by taking a weighted net average cost per course multiplied by the number of courses in the term. The average cost of course materials varies by degree type.
- For all students eligible for the military tuition rate, the course materials charge will be posted to a student's account once each term only, after the add drop period. The charge will then be waived, resulting in no net cost to the student.
- A \$1,000 non-refundable fee is charged to a student's account each quarter in which a student is registered for symposium. This fee covers administrative costs such as conference rooms, AV equipment, academic event materials and supplies that are associated with the symposium event. BACHELOR OF SCIENCE IN NURSING (RN TO BSN COMPLETION PROGRAM)

The Bachelor of Science in Nursing (RN to BSN) completion program provides several opportunities for prospective students to reduce the total program length and cost through credit for academic or other experiences. Upon receipt, official transcripts or other documentation will be reviewed by CTU's Prior Learning Assessment Department to determine transfer credit eligibility into the RN to BSN program followed by any cost adjustments.

- Up to 90 quarter credits may be accepted as transfer credit with the required incoming Associate Degree in Nursing, Diploma Registered Nurse (RN), or a graduate-entry educational transition program preparing students for eligibility to become licensed as a Registered Nurse. - 28.5 quarter credits may be awarded toward degree completion requirements for a valid Registered Nurse (RN) license. [Click for details.](#)

STUDENT TUITION RECOVERY FUND : CALIFORNIA RESIDENTS ONLY

The State of California created the Student Tuition Recovery Fund (STRF) to relieve or mitigate economic losses suffered by students in educational programs who are California residents, or are enrolled in a residency programs attending certain schools regulated by the Bureau for Private Postsecondary and Vocational Education.

You may be eligible for STRF if you are a California resident or are enrolled in a residency program, prepaid tuition, paid the STRF assessment, and suffered an economic loss as a result of any of the following:

1. The school closed before the course of instruction was completed.
2. The school's failure to pay refunds or charges on behalf of a student to a third party for license fees or any other purpose, or to provide equipment or materials for which a charge was collected within 180 days before the closure of the school.
3. The school's failure to pay or reimburse loan proceeds under a federally guaranteed student loan program as required by law or to pay or reimburse proceeds received by the school prior to closure in excess of tuition and other costs.
4. There was a material failure to comply with the Act or this Division within 30 days before the school closed or, if the material failure began earlier than 30 days prior to closure, the period determined by the Bureau.
5. An inability after diligent efforts to prosecute, prove, and collect on a judgment against the institution for a violation of the Act.

You must pay the state-imposed assessment for the Student Tuition Recovery Fund (STRF) if all of the following applies to you:

1. You are a student in an educational program, who is a California resident, or are enrolled in a residency program, and prepay all or part of your tuition either by cash, guaranteed student loans, or personal loans, and
2. Your total charges are not paid by any third-party payer such as an employer, government program or other payer unless you have a separate agreement to repay the third party.

You are not eligible for protection from the STRF and you are not required to pay the STRF assessment, if either of the following applies:

1. You are not a California resident, or are not enrolled in a residency program, or
2. Your total charges are paid by a third party, such as an employer, government program or other payer, and you have no separate agreement to repay the third party.

The above referenced tuition assumes a student will be continuously enrolled, and satisfactorily completes all program requirements for graduation. The total tuition cost will increase due to academic failure of courses and or withdrawals and drops.
